- The Engine is sold "as new," and the Seller makes no implied warranties as to the condition or performance of the Engine, except as outlined in the original equipment manufacturer's (Verner Motor) written warranty conditions.
- If the Buyer does not perform their part of the agreement by the tentative date-of-sale, 75% of the Deposit (30% of the List Price) will be refunded.
- If the Seller does not perform their part of the agreement by the tentative date-of-sale, 100% of the Deposit (40% of the List Price) will be refunded.
